Dear Mr. Barnett:

As required by Rule 0400-11-01-.02(6)(b)1 of the Solid Waste Processing and Disposal Regulations, the Tennessee Department of Environment and Conservation (TDEC), Division of Solid Waste Management (DSWM), has reviewed your amended notification to the Permit-By-Rule for the Lighting Resources LLC (SWP900001576) facility received August 6, 2021. The amended notification was submitted to update the current permit to allow acceptance of Universal Waste Aerosol Cans for accumulation and shipping to a permitted Universal Waste Processor, update the Narrative of Waste Processing, the Narrative of Waste Acceptance, the waste tracking spreadsheets, and the floor plan. Additionally, this amendment increases the waste storage limit from 959.60 cubic yards to 969.50 cubic yards and includes an update to their financial assurance. This amendment allows only for the accumulation and shipping of the cans offsite. Lighting Resources LLC will not process or puncture the cans.

Therefore, DSWM is notifying you of the results of this review in accordance with Rule 0400-11-01-.02(6)(b)2(ii). DSWM approves the updated notification amendments for incorporation into the approved Lighting Resources LLC Permit-By-Rule as previously authorized by DSWM's letter dated January 5, 2021.

Per Rule 0400-11-01.02(2)(a)1(xxiii) solid waste processing facilities must file a financial instrument with the State of Tennessee in an amount sufficient to insure the proper closure of the facility. The new required financial assurance amount is \$124,554.00. Please contact TDEC's Division of Fiscal Services (DFS) at (615) 253-6367 for assistance concerning financial assurance.
