Re: Construction Quality Assurance (CQA) Review & Final Inspection of Phase 4 Cell 1

EWS Camden Class II Landfill (IDL 03-0212) (EWS)

Benton County

Dear Mr. White:

On August 7, 2015, the Division of Solid Waste Management (DSWM) conducted a final construction inspection of Phase 4 Cell 1 at the above landfill. On August 14, 2015, House Engineering LLC submitted final construction certification on behalf of EWS. DSWM has evaluated the CQA documents.

No deficiencies were noted during the inspection or review of the CQA certification. Therefore, Phase 4 Cell 1 of the landfill may be placed into operation upon receipt of this letter. However, EWS is requested to submit a revised as-built engineering drawing SV1 that provides additional storm water detail. Please delineate all storm water diversion berms and adjacent drainage pathways that correlate to the cell storm water run-on/run-off controls.

During placement of the first lift, heavy loaded trucks and equipment must be kept on top of the waste, not directly on the drainage layer. Sharp objects and bulky waste should not be included in the first lift especially while the waste relocation occurs. EWS must closely monitor initial operations within the new fill area until routine disposal activities are realized. Of special note, daily cover must be applied to each active disposal area within Phase 3 and Phase 4 in accordance with facility-specific permit conditions.
