**Proposed Permit Modification Permit-By-Rule Notification for a Solid Waste Processing Facility**  
**Lighting Resources, LLC – 2212 Buffalo Road Facility – SWP 900001576**

The Division of Solid Waste Management (DSWM) is in receipt of the proposed permit modification Permit-By-Rule (PBR) notification package for a Solid Waste Processing Facility dated March 23, 2023, and received on May 15, 2023, prepared by the facility in response to May 1, 2023 Notice of Technical Deficiency (NOTD) #2.

In accordance with the Regulations Governing Solid Waste Processing and Disposal in Tennessee, Rule Chapter 0400-11-01, the notification package documents for the above facility has been reviewed and discussed with Central Office staff for technical deficiencies. Based on this review, the notification application is deficient. The deficiency for the permit application is detailed below. If you wish to continue to revise the PBR notification package for a Solid Waste Processing Facility, a completed revised PBR notification package for a Solid Waste Processing Facility to address the deficiency should be submitted.

**Rule 0400-11-01-.02(2)(b)1.(XVIII)l. [Rule page 27]:**

Financial assurance for proper closure of the facility- The Closure Cost for properly closing the facility must not include the “Rebate/Credit” dollar figures or an estimated cost of “0” dollars for the wastes/materials. Please remove references to “Rebate/Credit” and “0” Costs and include an appropriate third party cost for management/disposal of all items.
