**Re: Special Waste Approval**

- (1) Leachate Treatment Solids from Industrial Waste Cell (IWC)
- (2) West Camden Landfill - (SNL 03 000 0247)

Dear Mr. Almanza:

Rule 0400-11-.01(4)(b) of the regulation promulgated under the authority of the Tennessee Solid Waste Disposal Act states that: "Except as may be specifically allowed in the permit, an operator may not accept for processing or disposal at his facility any special waste unless and until specifically approved to do so in writing by the Department."

This letter will serve as approval to the Former EWS Landfill for monthly disposal of 50 tons of solids generated from treatment of IWC leachate in the West Camden Sanitary Landfill (SNL 03 000 0247).

Based upon review of the submitted special waste application dated July 18, 2017 and the attached analytical report dated July 6, 2017, the Division of Solid Waste Management (DSWM) has determined the waste suitable for disposal in the West Camden Sanitary Landfill (SNL 03 000 0247) contingent upon the following conditions/restrictions:

- 1) If the physical or chemical properties of the waste change significantly, the Division must be immediately notified for re-evaluation.
- 2) Be advised that **no free liquids** may be associated with the disposal of this waste.
- 3) A composite sample shall be collected for every 10 totes of solids generated and analyzed for TCLP Cadmium. A copy of the specific analysis to each load must accompany that load when transported to the landfill.
- 4) The waste may be routinely managed with other solid waste at the facility.
- 5) The waste must be transported separately, which will facilitate management at the landfill.
- 6) The operator must have prior notice or prearranged schedule prior to transporting the waste to the facility.

If you continue to generate this waste you should be aware of Rule 0400-11-01-.01(4) which states:

- (i) Re-certify the accuracy of the information on a form provided by the Department every third year that there has not been a change in the waste stream or process generating the waste since the original approval was granted by the Department, and
- (ii) Recertification of this waste shall be submitted by July 1, 2020, and special waste approval will expire on July 1, 2020, if re-certification is not submitted.

Be advised that the facility operator may refuse to accept any special waste, even if it has been approved in writing by the Division.
