McCarthy Improvement Company, Inc. is requesting the termination of coverage under Permit No. TNG110426. The paving project at the McGhee Tyson Airport has been completed and the concrete batch plant has ceased operations as of January 28, 2017. The plant was dismantled and removed from the site by early February 2017. All discharges of process wastewater associated with the operation of the concrete batch plant and all storm water runoff associated with industrial activities to surface waters of the State have been eliminated.


