

Tennessee Valley Resident Comments on Modification of NPDES Permit No. TN0005452, Tennessee Valley Authority (TVA) Kingston Fossil Plant (KIF)

Submitted via Sierra Club

The following document contains 198 signatures, 85 of which are accompanied by additional personal messages. These signatures indicate broad and diverse support for TDEC to act to add a retirement selection into the permit so the community has certainty about when this plant will stop poisoning TN waters.

The following spreadsheet contains names and contact information of people who signed the letter below:

Kingston is a source of dangerous water toxics, discharging harmful pollution like mercury and arsenic into Tennessee's waters, and the best way to end this toxic pollution is to retire Kingston.

The final permit should incorporate TVA's compliance selection. There is an existing NEPA process wherein TVA is exploring retiring Kingston by 2026 and replacing this generation with solar and battery or gas plants, and this needs to be reflected in the NPDES permit application and plan.

The Kingston community and surrounding waterways including the Clinch River have had huge environmental and human health impacts from coal waste because of the Kingston coal ash spill in 2008 - the largest industrial spill in US history.

Because of this, the NPDES should follow the retirement pathway with the soonest possible retirement date and the least amount of coal waste discharge.
