Dear Mr. Rhodes:

This letter is to inform you the Division of Water Resources (division) is terminating the above referenced permit coverage effective as of the date of this letter. As stated in your letter, activities at 2055 Alcoa Highway that required an NPDES permit were discontinued.

Please note that all discharges of storm water runoff and process wastewater associated with Ready Mixed Concrete Facilities require an NPDES permit from the division. Therefore, if you should decide to again discharge, you should submit an NOI in accordance with the requirements of the NPDES at least 30 days prior to the starting of any activities.
