The paving project at the McGhee Tyson Airport has been completed and the concrete batch plant has ceased operations as of November 1, 2017. The plant was dismantled and removed from the site by December 1, 2017. All discharges of process wastewater associated with the operation of the concrete batch plant and all storm water runoff associated with industrial activities to surface waters of the State have been eliminated.






