The Tennessee Department of Environment and Conservation, Division of Water Resources (the Division), acknowledges the receipt of the above-referenced preliminary engineering report and preliminary plans. The report and plans describe the process for pilot testing two wastewater treatment technologies (WWT) for the flue gas desulfurization (FGD) waste stream at the TVA KIF site.

The pilot scale processes include 1) membrane-based treatment and 2) biological treatment followed by membrane-based treatment. The pilot studies are proposed to determine overall effectiveness and feasibility of these treatment options. The project is associated with NPDES Permit TN0005452. The pilot plants are internal to the overall site treatment processes and are not anticipated to change the volume or characteristics of the authorized discharge.

The pilot project is ancitipated to run approximately 30 days.

The Division has no objection to the pilot study. Any substantial changes to the project should be submitted to the Division for comment. The Knoxville Environmental Field Office (865-594-6035) should be notified at plant start up and termination of the pilot.
