1	2	Item 1.1.1.4, manifest record	Oak Ridge National Laboratory (ORNL) is fully staffed around the clock with Utilities operations personnel, emergency responders, and HAZMAT/Spill response teams to promptly address any unexpected incidents. Moreover, security personnel are stationed at the portal facilities at all times. The pump & haul (P&H) vendor accesses these facilities at their convenience. Given the extensive resources available, ORNL is well-prepared to handle any spills that may occur. The P&H vendor also has a contract requirement to immediately notify ORNL in the event of a spill. Therefore, we respectfully request the elimination of the requirements for an ORNL representative to be present during transfers by the P&H vendor and recording of the names of individuals present during P&H activities in the required operating reports.
2	2	Item 1.1.4, reporting	We request that the Monthly Operation Report submittal frequency be adjusted to quarterly instead of monthly to align with reporting requirement from existing SOP-22033, where TDEC agreed to quarterly reporting.
3	10	Item 3.2, signage	DOE agrees with the need to inform the public of such facilities by placement of signage. However, these portal facilities are not readily accessible to the public, as they are located on DOE property at the security entrance portals. We request that no signage be required at these facilities.
